CONTRACTOR CASH ACCOUNT

The periodic rate will be added monthly, based on the average daily delinquent balance.

Delinquent accounts may also be subject to late fee. The periodic rate will be added monthly, based on the average daily delinquent balance. All accounts to be paid in full by cash or check.

AGREEMENT TO PAY COLLECTION FEES
